#### THE CORPORATION OF THE TOWNSHIP OF HILTON

BY-LAW NO. \_1344-22

Being a by-law to provide for a change in voting locations for the School Board Trustee Election in 2022 for the Township of Hilton.

WHEREAS Section 43 (1) (2) of the Municipal Elections Act, 1996, provides that a municipality shall hold an Advance Vote on one or more dates and the Clerk shall establish the date and number and location of voting places for the advance vote;

AND WHEREAS Section 45(3) of the Municipal Elections Act, 1996 provides that voting places may be located outside the voting subdivision and outside the local municipality;

AND WHEREAS there has been an acclamation to office for all Council positions for the Township of Hilton and there is only a need for the election of a School Board Trustee;

NOW THEREFORE the Council of the Corporation of the Township of Hilton hereby enacts as follows:

- 1) One Advance Vote shall be held on Saturday, the 15th day of October, 2022 between the hours of 10:00 a.m. and 5:00 p.m. at the St. Joseph Township Municipal Office, 1669 Arthur Street, Richards Landing, Ontario.
- 2) The Regular Vote shall be held on Monday, the 24<sup>th</sup> day of October, 2022, between the hours of 10:00 a.m. and 8:00 p.m. at the Royal Canadian Legion, 1534 10<sup>th</sup> Side Road, Richards Landing, Ontario.
