Reeve Wood welcomed members to the Inaugural Meeting of the 2018 to 2022 term. The members present took their Oaths of Office.

There were no disclosures of pecuniary interest.

The Road Superintendent provided an update on road issues in the Township. There were a variety of problems with the sander recently which involved down time with the truck as the Road Super carried out repairs. During this period Chris Burton was hired to sand our roads. The sander is now once again operational.

Clarifications were received regarding the split between equipment and truck costs on the recent plowtruck tenders received. The following resolution was passed.

The Clerk advised Council of correspondence with residents from Red Maple Drive concerning the frequency of plowing to that road. The Clerk was asked to confirm the terms of the plowing agreement with all Red Maple Drive residents currently sharing in the contracted costs.

Resolved that we do agree to provide winter plowing services for the 2018-2019 season on a requested or 'as needed' basis to be determined by the Road Superintendent for Red Maple Drive with such services to be provided at an hourly rate of \$145. Resolved that we do agree to plow the end of Jocques Bay Road for the 2018/2019 winter season to allow for the parking of vehicles off the highway. * Carried *

The Clerk advised Council of recent phone calls received from residents of the Village of Hilton Beach regarding the Township's plowing and sanding of the hill areas within that community. In addition, Council reviewed email correspondence from one of the Village residents. The issues involved with plowing/sanding this area were discussed and Council directed the Clerk to contact the Village Council to arrange a meeting to discuss the matter.


