Lyn Garside, Road Superintendent, provided an update on road issues in the Township. The plowtruck had been taken in for its annual inspection as well as the Drive Clean test required every second year. Significant costs were incurred due to a number of various repairs. The work was determined worthwhile given plans to recondition this vehicle into a tanker for the Hilton Union Fire Department in the coming year.

At this time Reeve Wood welcomed Mayor Robert Hope and Tom Desjardin and his family. Desjardin Construction Ltd. had been contracted jointly by the Village and the Township to complete concrete work at the Cenotaph in the Village as part of its full restoration. As a personal gesture, Mr. Desjardin had ordered a special plaque to be made commemorating the site and presented it to both Heads of Council. Both municipal leaders and all of Council noted their appreciation of the plaque and efforts would be made to erect it prior to Remembrance Day.

The meeting continued with the Road Superintendent confirming tender packages for a new plowtruck had been circulated with a closing date of November 19, 2018 at 2:00 pm. Council agreed to meet that day to open submitted tenders.

Seconded by Dave Leask Resolved that we do agree to provide winter plowing services for the 2018-2019 season on a requested or 'asneeded' basis to be determined by the Road Superintendent from the turnaround on Garside Road West to the end of Ellwood Boulevard with such services to be provided at an hourly rate of \$145. Council reviewed a request from St. Joseph Township to enter into a joint agreement regarding maintenance to the section of K Line west of the 20th Side Road. The Municipal Act requires shared jurisdiction roads be governed by an agreement. This issue was addressed by both municipalities in 2004 and the agreement reached at that time was that St. Joseph Township would maintain this section of road and Hilton Township would maintain the section of K Line off of Canoe Point Road. The agreement was never formalized in writing. The K Line section off of the 20th is designated a 'non-maintained' road within Hilton Township's inventory of roads. The Clerk was directed to contact St. Joseph Township to confirm Hilton Township would be willing to enter into a formal agreement continuing the maintenance responsibilities as they have existed since 2004.

Council was advised of an Emergency Training session to be held in Plummer Township available to all area municipalities. Our CEMC, Jim Waycik, plans to schedule our own training session within the next month involving a thorough review of our updated Emergency Plan. A date of November 21, 2018 at 7:00 pm was agreed to for this training.

Council noted the benefit in members familiarizing themselves with the layout of the Grace United Cemetery prior to it being transferred to the Township. It was agreed that following the afternoon meeting on November 19, 2018 to review tenders for the plowtruck that attending Council members and staff proceed to the cemetery. The Clerk recommended some of the current Grace United Cemetery Board Members who have been taking care of the site over the past several months be asked to take part.

FIRE - 911 for Emergencies

How do I prevent a heating fire?

- Have your heating system and chimneys inspected and cleaned annually by a qualified service technician.
- Ensure all outside heating vents are not blocked.
- Ensure woodstoves, fireplaces and fireplace inserts are installed by a qualified technician according to manufacturer's instructions.
- Always use a fire screen around the fireplace.
- Allow ashes from your woodstove or fireplace to cool before emptying them into a metal container with a tight-fitting lid. Keep the container outside.
- All homes with a fuel-burning appliance, fireplace or attached garage must have a working carbon monoxide alarm installed outside all sleeping areas.
