As of Monday, May 2, 2022 nominations may be made by completing and filing in the office of the Clerk, nominations on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100.00 for all other offices, payable by cash, certified cheque or money order.

Nomination forms are available at each Municipal Office during regular office hours. A nomination must be signed by the candidate and may be filed in person or by an agent during <u>regular business</u> <u>hours</u>* between May 2, 2022 and Friday, August 19, 2022, and between 9 am and 2 pm on Friday, August 19, 2022 (Nomination Day). All completed and filed forms are public documents.

A person is qualified to be elected or hold office who, as of the day they file their nomination:

- 1. Is a Canadian citizen
- 2. Is at least 18 years of age; and

- 3. Resides in the local municipality, or is the owner or tenant of land in the local municipality, or the spouse of such a person;
- 4. Is not disqualified by any legislation from holding office.

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 24, 2022 between the hours of 9:00 am and 2:00 pm, and such additional nominations, if required, may be filed in the respective Clerk's office.
